A protest is an objection to an Internal Revenue Service (IRS) ruling, decision, audit, or for other reasons, but the protest must be written. The appellate tribunal's role is to determine whether the IRS Appeals is a function of the assessment or of the appeal process.Chromosomal inversions, euchromatic tandem repeats and satellite DNAs in fish. The formation of inversions and rearrangements of euchromatin is one of the hallmarks of evolution. Here we report the presence of inversions in fish. In tuna a chromosome 4p inversion is present and may represent a new genetic marker. In gobiids (Aphanopus) we have observed three different sequences that map to different parts of the euchromatin.
