This handbook provides some useful suggestions of these programs and identifies which ones are best for your topics. *9 In support of their civil rights claims, the plaintiffs submit that (a) the police arrested them without probable cause, in violation of the Fourth and Fourteenth Amendments to the United States Constitution and Article I, § 8 of the Pennsylvania Constitution; (b) their arrest was in violation of section 1362; (c) their arrest and prosecution violated their first amendment rights to free speech, specifically their right to go to the polls and petition the government for a redress of grievances; and (d) their arrest, detention and prosecution also violated their first and fourteenth amendment rights to freedom of association and freedom of religious expression, specifically their right to hold services at the motel, as well as their right to refuse to be associated with the political and religious views of the pastors at the motel. Plaintiffs submit that the district court erred in ruling that their section 1983 claim for violations of their first, fifth, and fourteenth amendment rights to freedom of association and freedom of religious expression, as well as their section 1983 claims for violation of their first and fourteenth amendment rights to free speech, were barred by the statute of limitations. They submit that these four amendments, as well as their section 1983 claims for violation of their first amendment right to free speech, were asserted in a timely fashion. As to the remainder of their section 1983 claims, the plaintiffs argue that the district court erred in ruling that their disorderly conduct conviction did not preclude section 1983 liability for arrest without probable cause. They argue that their conviction should have barred only their section 1983 claim for malicious prosecution. Since none of their section 1983 claims is barred by any statute of limitations, they submit that they should be afforded an opportunity to prove their claims of unlawful arrest, false arrest, and malicious prosecution.



For these reasons, I would find that the Reliance Provision violates the First Amendment right of free association because it has a significant impact on union members and fails to advance the Government's legitimate interest in providing a stable workforce.
